Here are a few points. We especially wish to note the vaccine makers have been totally released from any liability if there is a negative side effect or death from the vaccine. However, if your employer or your university is forcing this on you, THEY have the potential of being held liable. It might be worth telling them about that!

Things to consider before you decide:

- Your Option to Refuse is based on Federal law over EUAs.
- Your Right to Informed Consent based on Federal law over EUAs.
- There are NO long term studies of side effects.
- Short term evidence of severe side effects and death.
- If you have had Covid you have immunity.
- All vaccine makers have been totally released from ALL liability for any side effects or death.
- There is liability potential on employers who mandate the vaccine if there are side effects or death.

Links to pdf forms to print out and give to your employer or to a university where your children may be attending. It makes sure that they are on record as providing the answers to questions surrounding the vaccine and potential after effects.

'Form Exemplars' for you to use or to consult with an attorney.

- Assumption of Liability – in the case of mandatory vaccinations to retain employment or for other work or school related benefits, consider to demand that the employer or school have an authorized representative sign the assumption of liability agreement. A refusal to sign this will make more clear your right to refuse the job to the organization pressuring you.

- Religious exemption – in the case of mandatory vaccinations to retain employment or for other work or school related benefits, if you have a religious basis to be exempt, consider the drafts provided here. If your basis for an exemption differs, draft your own, or have an attorney draft a version using these examples but consistent with your religious reason. Despite what some employers and government officials are trying to claim, your personally held religious beliefs are protected even if they differ from the opinions of religious leaders.

Monday, the U.S. Food and Drug Administration (FDA) [approved](#) a [biologics license application](#) for the Pfizer **Comirnaty** vaccine.

First, the FDA acknowledges that while [Pfizer](#) has “insufficient stocks” of the newly licensed **Comirnaty** vaccine available, there is “a significant amount” of the Pfizer-**BioNTech COVID** vaccine — produced under [Emergency Use Authorization](#) (EUA) — still available for use.

The FDA [decrees](#) that the Pfizer-**BioNTech** vaccine under the EUA should remain unlicensed but can be used “interchangeably” ([page 2, footnote 8](#)) with the newly licensed Comirnaty product.

U.S. laws, however, permit employers and schools to require students and workers to take **licensed** vaccines. **Is the licensed vaccine available in your area?**

At least for the moment, the Pfizer Comirnaty vaccine has no liability shield. Vials of the branded product, which say “Comirnaty” on the label, are subject to the same product liability laws as other U.S. products.

Pfizer is therefore unlikely to allow any American to take a Comirnaty vaccine until it can somehow arrange immunity for this product.

Ask to see the vial. If it says “Comirnaty,” it’s a licensed product.

If it says “Pfizer-BioNTech,” it’s an experimental product, and under [21 U.S. Code 360bbb](#), you have the right to refuse.

If it comes from Moderna or Johnson & Johnson (marketed as Janssen), you have the right to refuse.
